There are several Memorandum of Understandings (MoUs) with other Institutes for exchange of Academic Support Facilities, Internships, Training & Placements etc. Pools of Add-On Courses are available for Skill Development and Career Advancement of the Students. Apart from that, this college offers facilities for Open and Distance Learning through NSOU Study Centre. Social Outreach Programmes are operative through an active NSS Unit and a vibrant NCC Unit. The college has legacy of achieving Medals and Prizes in Games and Sports Activities in State and National Level Competitions. Through these extracurricular and Cultural activities throughout the year, the college seeks to ensure its steady progress and all-round development.

## AND

RIGHT BRAINS TECHNOLOGY, a private concern, having its Office at Ground Floor, Sanghoti Abasan, Garia Main Road, P.S. Narendrapur, Kolkata-700084, represented by its Proprietor Sri Rajib Mukherjee, son of Sri Ananda Gopal Mukherjee.

## Scope:

Kalyani Mahavidyalaya encourages advancement of learning via Need-based Education. The college desires to provide career-oriented academic advantages to students through online repository of resources for competitive examinations called 'Entry in Service Examinations' portal in collaboration with Right Brains Technology, a registered software company. Parallelly, the college also desires to upskill and re-skill its teachers and staff w.r.t various emerging academic and administrative digital platforms. Right Brains Technology has agreed to the said proposal.



This *Memorandum of Understanding (MoU)* witnesses that both the organizations wish to explore the possibility of collaborating in various ways including:

- (a) That for the above-mentioned purpose both the organizations have agreed to start the 'Entry in Service Examinations.'
- (b) The Placement Cell of the college will oversee the contents of the said portal and look after the day-to-day activities.
- (c) That Right Brains Technology will render and provide the online resources for competitive examinations, technical advice and assistance to the students who enroll themselves for the said benefit.
- (d) That the fee for accessing the said portal will be Rs.150/- (Rupees One hundred and fifty only) per year which is to be deposited in the College Account and the student who thus registers will have access to the same for that particular year of her course of study in the college.
- (e) Both the organizations will take necessary permission/ approval from the concerned Authorities regarding the above matters.
- (f) Both the organizations have agreed that if additional assistance is required, Principal of Kalyani Mahavidyalaya and Mr Rajib Mukherjee of Right Brains Technology will settle the matter mutually after discussions.
- (g) That in respect of the above-mentioned collaboration only the Principal of the college will take all responsibilities regarding selection of candidates/ participants and other matters of the said purpose.
- (h) The College can provide Students only but the college will not take any financial responsibility.
- (i) That Right Brains Technology will be entitled only to 90% of the registration fee from the College for the provision and maintenance of the said amenity.
- (j) That Right Brains Technology will organize various Add-on/ Certificate courses for students as per the requirement of Kalyani Mahavidyalaya.
- (k) That Right Brains Technology will arrange various Faculty Development Program, Professional Development program etc. from time to time to train the teachers and staff of the college as per need.
- (I) The fee for such Development programs/ Certificate courses will be decided mutually by both the organizations on a case-to-case basis.

## Terms of the MoU:

The terms of Understanding for each specific activity implemented under this agreement shall be mutually discussed and agreed upon in writing by both the organizations prior to the initiation of that

activity. Such agreements will have full regard to issues of quality assurance and budgetary matters and may be subject to legal contracts as agreed by the institutes.

This MOU shall be valid for a period of 5 years. It may be amended, modified, extended, or renewed only by the written consent of both institutions. The organizations agree to review this agreement six months prior to the end of the 5-year term. This MoU may be terminated at any time by mutual consent or by 6 months' notice by either side.

## Disputes:

If any disputes arise in respect of this Agreement, then Principal of the College and Mr Rajib Mukherjee will discuss and settle the matter amicably.
