1. BACKGROUND:

- (a) RICE is a reputed Educational Institution imparting education among the young generation of the society, who are seeking for Government job/s.
- (b) Kalyani Mahavidyalaya is a reputed college in the City of Kalyani affiliated under the University of Kalyani.

Both the parties herein have noted the importance of training in competitive examination to secure government service and to collaborate with each other towards training to the students of KALYANI MAHAVIDYALAYA by RICE on competitive examinations conducted by the Central and/or different State Governments and/or different Service Commissions in India and accordingly desires to on mutual co-operation with each other.

2. AREA OF CO-OPERATION:

Both the parties herein have identified the following areas of mutual co-operation:

- RICE will train the students of KALYANI MAHAVIDYALAYA for several (i) competitive examinations, which includes WBCS Course, SSC, Bank, Foundation, and any other courses may offered in future by RICE Education
- KALYANI MAHAVIDYALAYA will sensitize its UG students and alumni (ii) for training;
- Conducting offline & online courses classes for the students of Kalyani (iii) Mahavidyalaya, where offline classes will be held at college premises or nearby RICE Education branch, (preferably at Belgharia (HO).
- Kalvani Mahavidyalaya will set up a dedicated room for counseling session, (iv) mock test etc.

3. SCOPES:

- Classes to be conducted on both online and offline mode; (i)
- Online classes to be held 4 to 5 days in a week and doubt clearing classes (ii) through offline mode to be held on Saturday or Sunday once in a Month at College premises.
- (iii) Offline classes to be held at the class rooms provided by Kalyani Mahavidyalaya and also in the nearby centers mainly at Belgharia;

4. RESPONSIBILITIES OF:

(A) RICE:

(i) to conduct both offline & online classes for the students of Kalyani Mahavidyalaya;

- to provide faculties for both offline and online classes and also for doubt clearing classes;
- (iii) to prepare a routine on consultation with Kalyani Mahavidyalaya;
- to prepare and provide course material, examination question paper/ answer sheet to each students of all batches for both offline and online mode;
- (iv) will offer exclusive batch structure for college UG students and alumni;
- (v) based upon the admission of number of students, RICE will offer a special pricing for the students and alumni of Kalyani Mahavidyalaya;
- (vii) to collect the prescribed fees as set out in Annexure -1 from the students;
 - (viii) to conduct regular free mock test for counseling and sensitization of students and alumni of Kalyani Mahavidyalaya.

(B) Kalyani Mahavidyalaya:

- to arrange and motivate the students for the aforesaid courses conducted by RICE and provide the list of interested students to RICE;
- (ii) to provide classrooms for offline classes;
- (iii) to assists the faculties of RICE;
- (iv) to ensure smooth functioning of the courses to be conducted under this understandings;
- (v) to support RICE to conduct offline classes in the college premises with audio/video support/facilities, as and when required;

(C) JOINT & OTHER RESPONSIBILITIES:

- (i) Both the parties shall co-operate with each other for implementation of the programme under this understandings;
- (ii) To promote the course/s under this MoU, both parties shall take initiatives to organize and/or conduct various seminars, webinar for the students of the Kalyani Mahavidyalaya;

- Online classes shall be conducted by RICE for 4 to 5 days in a week and the doubt clearing classes to be held on Saturdays/Sundays through offline mode;
- (iv) The representatives of both the parties shall meet with each other to supervise the progress of the courses/programmes to be conducted under this MoU;
 - (v) The parties shall exchange in writing the name on its behalf as the "Ponit of Contact";
 - (vi) On recommendation of the Kalyani Mahavidyalaya, RICE shall allow 20% scholarships at RICE HO Belgharia for offline courses as prevailing fees structure for offline courses.
 - (vii) Considering the number of admission of the students of Kalyani Mahavidyalaya, RICE may, at its discretion offer a "Special Pricing Offer" on course fees for those admitted students;
 - (viii) RICE shall solely responsible to prepare the notes, course materials, question papers, answer sheets, class routine, syllabus and take the exams, evaluate papers etc.;
 - (ix) Kalyani Mahavidyalaya shall co-operate with RICE in all such activities for implementation of the understandings;

5. INTERPRETATION AND CONSTRUCTION:

Any ambiguity of the terms and conditions of this Memorandum of Understanding resulting in conflicting interpretations shall be settled by both parties through mutual consultation or negotiation.

6. AMENDMENT, DURATION AND TERMINATION:

- Any Amendments to this Memorandum of Understanding shall be made by mutual consent and signed by both parties;
- (ii) This Memorandum of Understanding shall be in effect from the date of its signing and shall be valid for a duration of 01 (ONE) year(s) from the said date and may be renewed thereafter on mutual understanding;
- (iii) This Memorandum of Understanding may be terminated by either party through a written notice of 3 (three) months in advance to the other party. However, earlier termination shall not affect the ongoing programmes and/or activities and the same

will be implemented as planned, unless otherwise agreed between the Parties.

7. FINANCE:

- A. Neither of the Parties to this understandings will charge any other fees/ commission from the other party, save and except the fees for the courses conducted by RICE under this understanding and the said fees will be collected by Roy's Institute of Competitive Examination Pvt. Ltd directly from the students.
- B. Course Fees for the programme under this understanding is set out in Annexure -1.

8. SETTLEMENT OF DISPUTE:

The Parties consider this Cooperation as a declaration of intent that does not have the legal force of a formal legal contract. The Parties agree that disputes, if any, shall be settled amicably.
